Not one time has anyone ever acknowledged the crimes committed by initially Douglas vernon duncan, then Sherry Mingle Duncan, then Robert Dee Rose, then Douglas Vernon Duncan. Each defrauded Keith Duncan of his very own registered assets. Each accused then filed Temporary Protective Orders TPO to stop all criminal investigations into their lifetime criminal sprees of defrauding and physically robbing Keith brent Duncan of his assets, withdrawing all his bank accounts, withdrawing all his 401K retirement assets, selling off all his lifetime assets, theft by conversion of his intellectual property of +15 patents of IseeStand.space, TurnOffLights.com (smartBreaker.us, LaserTunnel.com JoyDrive.us, SmartSmoke.us) and the most critical anti-all

crime systems of UNlocracy.org focusing on use of one international Voting system Evote.one and One international open public database FOIA.ONE.

The basic crime was always Illegal Detainment based on the crimes of each person named in this class action lawsuit.

1st was 7 days May 2009 at Peachtree Charter Medical Hospital after Sherry Duncan and Kyle Duncan assaulted Keith after Sherry refused to sign the postnuptial financial divorce agreement spring 2009 resulting in Kyle Duncan brutally assaulting Keith Duncan dislocating our right shoulder requiring surgery.

Assault on Oct 15, 2018 broke Keiths nose, jaw, and eye socket when Keith was illegally and criminally held at Georgia Regional Mental Hospital Oct 6, 2011 to on or about Nov 15, 2018 after Atlanta FBI Agent LYNN criminally ordered Keith to be medically evaluated on UNSIGNED statement by any judge that Keith was **“grandious dillusional for going TO FBI and POLICE”** continuously since Feb 4, 2011.
